## CONDITIONS OF PLAY

### 1. STATUS

- 1.1. These Conditions of Play are made under Law 55.3 of the Laws of the Sport, which permits Bowls Auckland as the Controlling Body to establish conditions of play to cover certain aspects of the sport.
- 1.2. The Conditions of Play set out the conditions of play for the September Quad 2024 and applies to all players, clubs and centres participating in the event.

### 2. EVENT SCHEDULE

- 3.1 Name of this event            September Quad 2024
- 3.2 Date(s) of event            Saturday 28<sup>th</sup> & 29<sup>th</sup> September 2024
- 3.3 Event venue(s)            Remuera, New Lynn, Royal Oak and Orewa Bowling Clubs

### 3. CONTROLLING BODY

- 4.1 The Controlling Body is Bowls Auckland, led by the appointed convenor and with support from Bowls North Harbour,
- 4.2 The controlling body will comprise those named on page two including staff and umpires, with any decisions made finally by the convenor.

### 4. TRIAL ENDS / PRACTISE

- 5.1 Under Law 5.1 of the Laws of the Sport, one set of trial end(s) will be allowed before a player or team's first game of the day only.
- 5.2 Where a rink is available, substitute players can request free practice at the discretion of the duty umpire.

### 5. COMPOSITION OF REPRESENTATION

- 5.1 1-5's – Ten players plus up to two reserves
- 5.2 Premier and Development – Seven players plus up to two reserves
- 5.3 A list of named players, team officials, manager(s) and coach(s) must be completed on the prepared form and provided to the Tournament Director before the close of business on **Friday 22<sup>nd</sup> September.**
  - a. Any amendments can be made up until the trial ends commencing. (09:30 am) via venue umpire
  - b. Team officials may also be used as playing members, should no reserves be listed.
- 5.4 Any Player can play in any round in any of the combinations. Each round will consist of a side made up of 1x Singles, 1 x Pairs, 1 x Triples (1-5's only) and 1 x Fours.

### 6. EVENT FORMAT

- 6.1 The four Centres will be drawn into one section, completing a full round-robin draw.
- 6.2 Each Centre will compete against its scheduled opposition in all disciplines simultaneously.
- 6.3 Only Players included on the official entry form are eligible to compete. (or those subject to clause 5.3)

### 7. PLAYING FORMAT (applicable to both Men and Women)

#### 7.1 Playing sides

- (a) Singles      4 bowls    21 Shots    or 2.0 hours
- Pairs        3 bowls    18 ends    or 2.0 hours
- Triples      2 bowls    18 ends    or 2.0 hours (1-5 grade only)
- Fours        2 bowls    15 ends    or 2.0 hours

- (b) The time signals for each game shall be as follows:

The commencement of play and the expiry of time shall be signalled by the Umpire by a bell or venue alarm, clearly audible to the Players concerned.

Where a game's time limit is not common to all general timekeeping, the Umpire shall notify the opponents or skips in individual games when the time limit has expired.

- (c) If in a time-limited game, the jack has been delivered before the time signal the end continues and if it is subsequently made dead it should be replayed until it is completed.
- (d) Ends made dead shall be replayed under Law 20 of the Laws of the Sport.

- 7.2 **Absentee Players:** If, by the latest scheduled start time, one or more Players are absent from a team, the defaulting team will forfeit the game to their opponents.

#### 7.3 Scoring

- (a) Teams will be awarded two game points for each game won and one point for each game drawn.
- (b) Based on the head-to-head match (consisting of three/four games), the side with the highest game points will be awarded two match points. If game points are equal, then the sides will be awarded one match point each.
- (c) The winning Centre shall be determined in order as follows:
  - (i) highest match points
  - (ii) highest game points
  - (iii) highest net total of shots
  - (iv) highest total of shots for
  - (v) in the unlikely event that two Centres remain tied after (iv) above, the Centre that won the match when the two Centres met shall be the winning Centre. If that match was tied, an extra end shall be played between the Centres in all three disciplines. The Centre that wins two of those three ends shall be the winning Centre.

### 7.4 Alterations to the format & length of games

- (a) The Controlling Body reserves the right to alter the format, times of play and greens to suit local unforeseen circumstances, giving as much notice as practical.

### 7.5 Restricting the Movement of Players

In time-limit games as per this Regulation, the movement of players during the play shall be restricted as specified in Appendix A. 4.1 - Laws of the Sport as follows:

- (a) After delivering their first bowl, players will only be allowed to walk up to the head under the following circumstances.
- (i) **Singles (each Player playing four bowls)**
    - After delivery of their third bowl and fourth bowls
    - In extreme circumstances, a player may request to visit the head before their third bowl, at the permission of the umpire
  - (ii) **Pairs (each Player playing three bowls)**
    - Leads after delivery of their third bowl; and
    - Skips after delivery of their second and third bowls.
  - (iii) **Triples (each Player playing two bowls)**
    - Leads after the second player in their team has delivered their second bowl.
    - Seconds after delivery of their second bowl
    - Skips after delivery of each of their bowls.
  - (iv) **Fours (each Player playing two bowls)**
    - Leads after the second player in their team has delivered their second bowl.
    - Seconds after delivery of their second bowl
    - Thirds after delivery of their second bowl
    - Skips after delivery of each of their bowls.
- (b) If a player does not meet the requirements of Appendix A.4.1, Law 13 of the Laws of the Sport shall apply.

### 7.6 Defaults

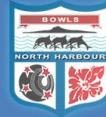
If a team or Player defaults their score will be recorded as a loss. The non-offending team will be awarded a win and the average total of shots scored for and against by the winning teams in the same discipline in the same round of the same section.

### 7.7 Coaches

It shall be permissible for any Coach to advise Player(s) on their side during the Event under Law 44 of the Laws of the Sport from outside the boundaries of the green.

## 8. SUBSTITUTES

- 8.1 Substitutes shall be allowed between games as outlined in the event format above.

8.2 Substitutes shall be allowed during a match with the approval of the umpire, in accordance with law 32.9 & domestic regulations section two (2), provided the substitute entering play has been listed on the official team entry list.

### 9. FOOTWEAR AND CLOTHING

9.1 Footwear to be in line with law (appendix A.2.2) and domestic regulations section 13

9.2 Any Player with a physical disability may use appropriate support, wheelchair or bowling aid, provided that the same is so made that its use causes no damage to the green.

9.3 Members within each team/side must wear garments of the same colour/design as determined by the tournament Controlling Body. This means all members of a team/side wearing the same colour trousers/shorts as well as shirts/tops. Any garment may have logos displayed, but the Controlling Body may impose conditions relating to sponsors logos to ensure there is no conflict with a tournament sponsor. **(No sponsor conditions for this event)**

9.4 Failure to comply with clause 9.3 will result in the offending team or side being defaulted for each round until they comply with clause 9.3.

### 10. SMOKING AND ALCOHOL

(a) There shall be no smoking anywhere in the clubhouse, on the greens, or under the covered facility. Smoking may only occur in designated smoking areas as advised by the host club.

(b) The drinking of alcohol is restricted to the clubhouse or designated areas at each venue. Drinking alcohol on the greens or immediate surroundings is strictly prohibited.

(c) Players are discouraged from drinking until all play is completed.

### 11. JURY OF APPEAL

11.1 A Jury of Appeal shall be appointed by the controlling body to decide upon any points not provided in the Conditions of Play and/or for dealing with any referrals or appeals from decisions made by Technical Officials (Law 43.2.6), under Bowls NZ code of conduct.

### 12. MEDIA

12.1 This event is not scheduled to be broadcast.

12.2 Photos or short-form video will be captured during this event.

12.3 By entering this event: Players, coaches, managers, and any other supporters acknowledge the right of the Host centre, participating centres, controlling body and host venues to use any photographic or short-form video taken during the event for the benefit of the promotion of the event and the game of bowls. Including but not limited to posting content to social media, websites, and physical publications.
